This notice explains important changes that have been made to AvSuper's High Growth investment option. Please read this notice carefully, to ensure that you are aware of these changes, how they will affect you and the date from which the changes take effect.

AvSuper's High Growth investment option

Effective 1 February 2020

We provide members with exposure to a well diversified range of investment options to give members a choice of investment style to suit their risk appetite and retirement savings horizons.

The Trustee sets long-term investment performance objective for each option and regularly reviews the appropriateness of the objective (relative to the prevailing economic environment and outlook) and measures how performance compares to the set objective.

What are the changes?

We have made some changes to the long-term investment performance objective for the High Growth investment option, as shown below:

THE OBJECTIVE FOR THE HIGH GROWTH OPTION IS TO ACHIEVE A RETURN, AFTER TAX AND FEES, OVER A ROLLING 10-YEAR PERIOD WHICH EXCEEDS CONSUMER PRICE INDEX (CPI) BY AT LEAST		
	TO 30 JANUARY 2020	FROM 1 FEBRUARY 2020
for Accumulation members	4.5%	4.0%
for Income Stream members	5.0%	4.5%

Remember: the long-term investment performance objective serves as a guide to the targeted performance of each investment option (after fees and taxes) under a range of market assumptions. You can see how our long term investment performance compares to our performance objectives on our website and in our Annual Trustee Report to Members. Importantly, while we are required by law to set long-term investment objectives, they are not a guarantee of future investment performance.

You do not need to do anything in response to this change unless you would like to consider making changes (Switches) to your investment choice options.
